I understand that there are risks and dangers in participating in martial arts activities and that in order to participate, in any such activities, including but not limited to Filipino Martial Arts, Indonesian Martial Arts, Kampilan Eskrima, Silat Buka Jalan, Aiki Training Muay Thai, Bahad Zu'bu, Kali Illustrisimo, Pekiti Tirsia Kali, Defensor Method of FMA, and other martial arts training involving the use of martial arts weapons, I must give up my rights to hold Promontory Point, Illinois Katipunan 2015, Defensor Method, Fitzgeralds Martial Arts Academy and any other entity, instructors or charity associated with Illinois Katipunan 2015, responsible or liable for any damage that I may suffer while participating in such training provided by Illinois Katipunan 2015, waiting at or on Promontory Point premises to participate in such training, walking through the premises at Promontory Point prior to or after such training. Knowing this and in consideration for being permitted to participate in martial arts training with Illinois Katipunan 2015. I hereby voluntarily forever release, discharge and hold completely harmless Illinois Katipunan 2015, and all other entities or charities associated with Illinois Katipunan 2015., and their members, offices, directors, agents, employees, heirs, assigns and independent contractors from any and all responsibility for, or liability resulting from or arising from, my participating in martial arts training at Illinois Katipunan 2015 in Promontory Point &/or Fitzgeralds Martial Arts Academy , and being on the premises at Illinois Katipunan 2015 in Promontory Point &/or Fitzgeralds Martial Arts Academy.

I understand that the martial arts training provided at Illinois Katipunan 2015 in Promontory Point &/or Fitzgeralds Academy may included, but will not be limited to, activities such as kicking, punching, hitting, stretching, twisting, jabbing, lunging, rolling, falling, jumping, yelling, hand locks, stickfighting, throws, chokes and the use of various martial arts weapons and equipment. I realize that these activities, as well as all other martial arts activities, can be dangerous, but I am voluntarily choosing to participate in some or all of these activities and agree to assume the risk associated with my participation therein.

I understand that I am assuming full responsibility for any and all risks of death, personal injury, emotional pain and suffering, property damage and economic loss that might be suffered by me as a result of my participation in martial arts classes at Promontory Point &/or Fitzgeralds Martial Arts Academy. I agree that this release shall bind me, my spouse, my heirs, my personal representatives, my assigns, my children and my and their agents.

I hereby further agree to release, indemnify and hold completely harmless Illinois Katipunan 2015, and all other entities associated with Illinois Katipunan 2015, and their members, officers, directors, agents, employees, heirs, assigns and independent contractors harmless from any and all liability and costs, including attorney fees, associated with or arising from my participating in martial arts training at Illinois Katipunan 2015 at PromontoryPoint &/or Fitzgeralds Martial Arts Academy, waiting at or on Illinois Katipunan 2015 at Promontory Point &/or Fitzgeralds Academy premises to participate in such training, and walking through the premises at Illinois Katipunan 2015 at Promontory Point &/or Fitzgeralds Martial Arts Academy prior to or after such training.

I understand that if I were to file a law suit against Promontory Point, Illinois Katipunan 2015, Defensor Method, Fitzgeralds Martial Arts Academy or any other entity associated with Promontory Point, Illinois Katipunan 2015, Fitzgeralds Martial Arts Academy and/or their members, officers, directors, agents, employees, heirs, assigns and independent contractors, as a result of any personal injury including death, emotional pain and Illinois Katipunan 2015 in Promontory Point &/or Fitzgeralds Martial Arts Academy, waiting at or on Illinois Katipunan 2015 Promontory Point/Fitzgeralds Martial Arts Academy premises to participate in such training, and walking through the premises at Illinois Katipunan 2015 in Promontory Point/Fitzgeralds Martial Arts Academy prior to or after such training, that this release would bar the lawsuit and the court would dismiss it on the grounds that by signing this release, I have expressly assumed all the risks associated with participation in such activities, including but not limited to negligence on the part of the martial arts instructors in the performance of their duties, negligence by other members of Katipunan 2015, Fitzgeralds Martial Arts Academy, & Promontory Point, negligence in the operation of machinery or equipment, and/or premises liability.

If I am signing this release on behalf of a minor child, I understand that I am giving up the same rights for the said minor as if I signed this release on my own behalf. I have read this agreement and understand the words and language in it and I am advised of all potential dangers incidental to participation in martial arts training Illinois Katipunan 2015 in Promontory Point/Fitzgeralds Martial Arts Academy, including travel to and from.
